## iii. Gasque

- 1. Ticket pricing
  - a. It turns out we need to spend more than anticipated, as we need to rent additional objects such as speakers, microphones, and lighting
    - i. In total we are planning on spending approx. 35000 sek on the gasque
      - 1. We calculating with the scenario of 60-70 people buying tickets
      - 2. For members, the final ticket price is:
        - a. 530 sek (with alcohol
        - b. 500 sek (without alcohol
      - 3. For non-members, the final ticket price is:
        - a. 580 sek (with alcohol)
        - b. 550 sek (without alcohol)
    - ii. We are planning on subsidizing the tickets with a total of 2200 sek
    - iii. We are also expecting the following income:
      - 1. Songbooks: 1500 sek (selling 30)
      - 2. Släpp entry: 400 (selling 5 tickets)
    - iv. No nation-card needed, so we can sell tickets to partners etc.
- 2. We could potentially apply to the student union for funding?
  - a. Greta will inquire regarding this
- 3. Things we need to do now:
  - a. Josefin will create the graphic and post the 'save the date'
  - Send out registration form for tickets by Wednesday next week,
    Dec 18
    - i. Registration and payment deadline is 12 days before the gasque
  - c. Linus will send out the invitations to other associations
